

# EPIF GROUP POLICY

## Bio-Diversity Policy

### 1. DEFINITIONS

For the purposes of this Policy the below mentioned terms are defined as follows:

<b>Biodiversity</b>	means the variety of plant and animal life in the world or in a particular habitat, a high level of which is usually considered to be important and desirable;
<b>EPIF</b>	means EP Infrastructure, a.s. and all companies that are directly or indirectly controlled by it;
<b>EPIF Group Company</b>	means any company which forms part of EPIF;
<b>Employees</b>	means all employees, directors and officers of EPIF Group and all persons working on a contract basis, whether on a temporary or a permanent basis, part-time or full-time;
<b>Policy</b>	means this Bio-Diversity Policy;

### 2. BIO-DIVERSITY

Economic and social development is closely linked to the use of natural resources, affecting not only the availability thereof, but also the integrity of ecosystems and the biological diversity thereof. As the preservation of the ecosystem is an essential condition for global sustainability, it is necessary for this development to be fully compatible with the environment. The scientific community agrees in noting that there is currently a serious decline in biodiversity as well as a degradation of ecosystems. This loss of biodiversity, a direct consequence of the impact of human activities, is occurring more rapidly and generally, which entails serious environmental, economic and social risks. EPIF is fully aware of these risks and aims to adopt measures allowing for the identification and eradication thereof, with a proactive attitude promoting biodiversity that goes beyond strategies of mitigating or containing damages.

During their respective life cycles, the EPIF Group's businesses cause interactions with various ecosystems, landscapes and species. EPIF therefore commits to promoting the biodiversity of the ecosystems, establishing new projects sustainably, allowing balanced co-existence, and conserving, protecting and promoting the development and growth of the natural heritage. EPIF also considers important to promote a social culture focused on promoting awareness-raising among all of its stakeholders regarding the magnitude of this challenge and the benefits associated with meeting it, identifying specific actions that contribute to the preservation and development of the environment and to the sustainable use of natural resources. These commitments are assumed and promoted through this Policy.

### **3. PURPOSE OF THE POLICY**

Encouragement of economic and social development, respect for the environment and promotion of biodiversity are paramount corporate values for the EPIF, informing all of its actions.

In this regard, this Policy confirms EPIF's commitment to sustainable and efficient development, as promoted through other EPIF Policies, such as Master Policy or Environmental Policy, recognising the strategic value represented by the preservation and promotion of biodiversity for all of the companies of the Group and providing a comprehensive and consistent framework of its commitments and underlying principles in the area of biodiversity.

### **4. SCOPE**

The Policy applies to all Employees in all countries and territories that EPIF Group operates in.

### **5. BASIC PRINCIPLES**

EPIF Group strives to prevent and minimise environmental impact, prioritising modernisation of processes and facilities, launching and maintaining the appropriate environmental management system standards and ensuring appropriate awareness among employees and business partners.

Protecting biodiversity in the areas where the EPIF Group operates is among the top goals of the EPIF Group. Potential risks in planning and operations are monitored and evaluated on a regular basis. These activities are complemented by consultations with experts, which leads to a mitigation of potential negative impacts. The EPIF Group aims not only to minimise the negative impact, but also to play an active role in supporting and protecting ecosystems and endangered species.

### **6. STANDARDS AND COMMITMENTS**

To implement its commitment to biodiversity, the EPIF Group shall be guided by the following main principles of conduct, which shall be gradually applied in all its activities and businesses.

#### **6.1. Regulatory Compliance**

The EPIF continuous goal is to be compliant with the current environmental regulation and to transparently cooperate with the regulators in each of the countries the EPIF Group operates in.

#### **6.2. Quality standards**

EPIF Group Companies ensure implementation and monitoring of the appropriate environmental standards and certifications (if required by law) relevant to their operations in the territories in which they manage their assets.

#### **6.3. Biodiversity as a Strategic Issue**

EPIF integrates the preservation of biodiversity into the strategy of the EPIF Group, including consideration thereof in decisions on the construction, operation and decommissioning phases of infrastructure projects.

#### **6.4. Preventive Approach**

EPIF applies a preventive approach to minimize the impacts of new infrastructure on biodiversity, bearing in mind the entire life cycle thereof. EPIF also incorporates this preventive approach into the environmental and social impact assessments of new infrastructure projects, particularly in natural areas that are sensitive, biologically diverse or protected. EPIF Group generally strives to avoid operating in areas with the highest biodiversity value.

## **6.5. Integrating Biodiversity into the Environmental Management Systems (EMS)**

EMS requirements are set up to ensure the implementation of procedures to protect the environment, identify risks and to ensure that the environmental performance meets the requirements of the regulation. The EPIF Group aims for maintaining or obtaining its certification standards at minimum meeting the regulatory requirements and if feasible also on par with international levels at major group companies.

## **6.6. Environmental Impacts of the Product Portfolio**

The EPIF Group aims to decrease its products' negative impacts and helps its customers to understand the environmental impacts of the products.

## **6.7. Resources Efficiency**

EPIF is committed to using all energy resources needed for its services' operations economically and efficiently, aiming for the highest sustainability standards in our present operations, reducing the waste generated, monitoring all resources usage and placing appropriate programmes to improve their efficiency.

## **6.8. Site Closures and Landscape Rehabilitations**

EPIF's efforts concerning the preservation of biodiversity do not end upon completion of the facility, but rather continue during the operation and decommissioning phases thereof.

EPIF's objective is to return the land disturbed by its activities to as close to its natural and beneficial state as possible and create viable habitats for native species of the local area. To this end EPIF dutifully fulfills all obligations resulting from relevant national jurisdictions such as creation of reserves, provisions and setting aside sufficient funds to cover site closure and landscape rehabilitation.

## **6.9. Promoting Biodiversity Through Education**

EPIF recognises the importance of providing environmental education and training to its key stakeholders through awareness-raising projects, energy efficiency programmes and by promoting renewable and clean energy solutions where appropriate.

## **6.10. Supporting Biodiversity Projects**

EPIF contributes to a wide array of projects in the area of biodiversity protection and restoration.

## **6.11. Engagement of Stakeholders**

EPIF collaborates with local communities, organisations, regulatory agencies and research institutes of national and/ or international repute in the field of biodiversity.

EPIF is committed to communicate its intentions in the area properly and in advance as well as to consult them with local authorities and general public.

## **7. IMPLEMENTATION**

The Policy is implemented by all EPIF Group Companies into their internal processes and rules of operations.
